This Dispatch Service Agreement ("Agreement") is entered into on _____, by and between:

1. Services Provided

Dispatcher agrees to provide the following dispatch services to Carrier:

- Searching for and booking freight loads;
- Negotiating rates with brokers and shippers;
- Assisting with load-related paperwork and documentation;
- Providing pickup and delivery information.

2. Carrier Obligations

Carrier agrees to:

- Maintain valid operating authority, insurance, and all required licenses with the FMCSA and DOT;
- Provide Dispatcher with accurate information regarding truck availability, equipment, and operational status;
- Transport all freight safely, lawfully, and in a timely manner in accordance with applicable laws and regulations.

3. Payment Terms

- Carrier shall pay Dispatcher 8% of the gross rate of each load booked by Dispatcher.
- Dispatcher will issue weekly invoices, and Carrier agrees to pay within 1 business day of receiving the invoice via Cash App, wire transfer, or check.
- Late payments may incur a 2% monthly interest fee on the outstanding balance.

4. Independent Contractor Relationship

Dispatcher acts solely as an independent contractor and is not an employee, agent, or partner of Carrier.

5. Liability & Indemnity

- Dispatcher is not liable for any cargo loss, damage, delays, or violations incurred during transport.
- Carrier assumes full responsibility for its own operations and compliance with DOT, FMCSA, and all other applicable regulations.
- Carrier agrees to indemnify and hold harmless Moore's Dispatch Solutions from any claims, damages, or legal actions arising from Carrier's services or conduct.

6. Confidentiality

Both parties agree to maintain the confidentiality of any proprietary or sensitive information exchanged during the term of this Agreement.

7. Term & Termination

- This Agreement becomes effective on the date signed below and remains active until terminated by either party.
- Either party may terminate with 7 days' written notice, or immediately upon breach of contract.

8. Dispute Resolution

This Agreement shall be governed by the laws of the State of Texas. Any disputes shall be resolved through

mediation or arbitration in the State of Texas.

9. Entire Agreement

This Agreement represents the entire understanding between the parties. Any changes or amendments must be made in writing and signed by both parties.
